Article 1

OBJECTIVE OF COOPERATION

The objective of this Memorandum of Understanding (MOU) is to cooperate in educational projects in areas of mutual interest

Article 2

SCOPE OF COOPERATION

Article 5

DURATION AND TERMINATION

- 5) This MOU shall into force on the date of signing.
- 6) The MOU shall remain in force for a period of five(5) years and may be extended for another period of five (5) years by the mutual written consent of the Parties.
- 7) Either Party may terminate this MOU at any time by giving written notification to the other Party on its intention to terminate this MOU, six (6) months prior to the date of the termination.
- 8) The termination of this MOU shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination.

Article 7


AMENDMENT

- 4) Such amendment/s or revision/s shall come into force on the date as may be determined by the Parties.


Article 8


